

How does Denmark affect foreign trade in electricity?

In Denmark, the foreign trade in electricity varies more than in any other European country. Foreign trade is strongly affected by price trends on the Nordic Electricity Exchange, Nord Pool, which is significantly influenced by the varying precipitation patterns in Norway and Sweden where electricity production is dominated by hydropower.

What can Denmark learn from the energy crisis?

Denmark can learn from the energy crisis with a view to prepare for the winter 2023-24, which will require a continuous focus on energy savings, renewables deployment, maximised energy production and the scaling up of clean energy investment. One lesson learnt is that demand-side flexibility can be enabled.
