Will Paladin Energy buy Fission Uranium?

MELBOURNE (Reuters) -Australia's Paladin Energy has received the final green light it needed from Canadian authorities to buy Fission Uranium in a C\$1.14 billion (\$789.1 million) deal that cements its position as a major global producer, it said on Thursday.

Did China influence Paladin's Investment Canada deal?

Paladin had hoped to close the deal by the end of September, believing it wouldn't raise any red flags, but Mr. Champagne ended up conducting a lengthy national security review under Section 25.3 of the Investment Canada Act. Under scrutiny by the minister was significant Chinese influence on both sides of the deal.

Will PALAF take over Canada's Fission Uranium?

Supplied Federal Industry Minister François-Philippe Champagne has approved Australia's Paladin Energy Ltd.'s PALAF takeover of Canada's Fission Uranium Corp., but he has imposed several conditions aimed at limiting China's access to uranium mined in Canada.

Did Paladin buy fission?

Perth-based Paladin reached a friendly agreement in June to buy Kelowna, B.C.-based Fission in an all-stock transaction worth \$1.14-billion. Fission is developing the Patterson Lake South uranium project in the Athabasca Basin region of Saskatchewan, which is estimated to hold about five per cent of global supply of the nuclear fuel.

Will Paladin get ICA clearance?

"In light of the national security review of the arrangement, there can be no certainty that Paladin will be able to obtain ICA clearance in a timely manner or at all," the company said in a filing, referring to the Investment Canada Act. "Failure to obtain ICA clearance would prevent the arrangement from being successfully completed."
