

What is a PV installation agreement?

The Installation Agreement is a lump-sum agreement between the project company, as owner of the project, and the installation contractor, the contractor that will be responsible for installing the PV system, providing the balance of plant and commissioning the plant.

What is open solar contracts?

As a response, the International Renewable Energy Agency (IRENA) and Terawatt Initiative (TWI) undertook a joint effort to simplify and streamline the contractual framework for solar power. The Open Solar Contracts initiative aims to unlock greater investments globally.

How are open solar contracts drafted?

The Open Solar Contracts are drafted on the assumption that the buyer is a national or local government-owned or government-controlled utility (but this also can be extended to private buyers authorised by the government). Furthermore, the offtake is assumed to be guaranteed in some form.

Can a framework be a public contract?

Frameworks that are public contracts are most likely to be awarded following a competitive tendering procedure. 8. Contracting authorities are permitted to directly award a framework under sections 41 or 43, provided the framework is not an open framework (section 49 (10)).

Are open solar contracts a good investment?

The Open Solar Contracts provide for a standard insurance package, but national regulations can have a very significant impact on the scheme to be implemented, with high cost consequences. The standardisation of insurance schemes is a key factor of bankability and risk management cost mitigation.

Can a contracting authority include estimated values in a tender notice?

If a framework is divided into lots, regulation 18 (2) requires a contracting authority to include the estimated values for each lot in the tender notice, if known. The contracting authority may also wish to include the estimated values for each lot in the framework itself although there is no requirement to do so.

appropriate, the quantity envisaged".
