

Photovoltaic panel installation span specification requirements

Do you need planning permission to install solar panels on your roof?

An increasing number of people are investing in solar energy. More and more homes are having solar panels, or solar tiles, installed on their roofs. Of course, with such installations, the topic of planning permission and building regulations often comes to the surface.

Do solar panels comply with building regulations?

Your solar panel system must comply with building regulations in terms of structural integrity, electrical safety and fire safety. These regulations may vary depending on the size and type of the installation. It's advisable to work with accredited installers who are familiar with these requirements.

When did solar panels become a building regulation?

In 2005, household electrical work was absorbed into the UK government's official Building Regulations. A year later, the Climate Change and Sustainable Energy Act 2006 brought microgeneration systems like solar panels under the umbrella of the Building Regulations. Should you receive a building regulations certificate for your solar panels?

What are the requirements for a PV installation?

Virtually all domestic PV installations will fall under the scope of Part P. Part P requires the relevant Building Control department to be notified and approve the work. There are two routes to comply with the requirements of Part P: Notify the relevant Building Control department before starting the work.

What is a photovoltaic solar system code section?

This collection of provisions imports code sections which address Photovoltaic Solar Systems, and the structural, fire safety and energy conservation measures for them. These are specific to Solar Systems.

How much space do you need for solar panels?

You will also need around 10 to 25 square meters of roof space available. The shape of the roof is not important. If there is any shade over the solar panels, this can have a large effect on the overall efficiency of the system.

The systems being installed in accordance with the relevant requirements of BS 7671, particularly Section 712, Solar photovoltaic (PV) power supply systems, and those of Section 551, Low voltage generating sets.
